Clermont County Port Authority Board of Directors - Special Meeting June 30, 2020

The Clermont County Port Authority Board of Directors met on Tuesday, June 30, 2020 at 11:00 a.m. in the Board of County Commissioners Session Room, Third Floor, County Administration Building, 101 East Main Street, Batavia, Ohio. Attending the meeting in person were Clermont County Port Authority Board of Director Chair, Loretta Rokey and Executive Director, Greg Bickford. Also present were County Commissioner David Painter; Gael Fawley, Department of Community and Economic Development; David Scheibenzuber, Office of Public Information. Attending the meeting virtually via Zoom were Board of Director Vice President, Matt Van Sant and Fiscal Officer, Sam DeBonis; County Commissioner Ed Humphrey; Steve Tugend and Andy Shifflette, legal counsel with Kegler Brown Hill & Ritter.
